2018 Financial Review & 2019 Budget presented by Bill Threlfall

- Operating 2018 as predicted and forecast.
- Operating 2019, slight increase due to fencing budget increase.

- Roads 2018 snow removal costs low, creating surplus in 2018, to be contributed to the contingency fund based on actual at year end. Spring maintenance expense under budget. Additional work being performed to compensate for heavy traffic. Snow fence expense in 2018.
- Roads 2019 remains the same as 2018.
- Overall, 2018 assessments to remain similar in 2019.
- Operating Contingency to grow to \$81,000 at year-end 2018, after the 2018 year-end contribution of approximately \$20,000.

Motion by Russ Szelag, second by Susan Curtis, to approve the proposed 2019 Budget as presented. *All in favor, motion passes unanimously.*

Discussion of short-term rentals per the association's rules and standards.
