Ranch Activities presented by Bill Threlfall

- San Miguel Power Association has submitted a request to hook into the electrical box and take it to lot outside the Association. Questions have been sent back to SMPA and a meeting is being arranged.
- Reports improvement in snow removal activities in 2019-2020. 4 years remaining in contract.

Proposed 2021 Budget presented by Bill Threlfall

Operating

- 2020 budget was \$154,000. The actual year to date is \$146,000. There is \$16,000 surplus in the operating.
- 2021 proposed budget is very close to last year.
- Budget forecast is similar to 2020 and is up marginally from last year due to increase in fence repair.
- Fence performance presented by John Merz.
- Discussion of neighbor ranch, Good Shepard Ranch re-organization. Mary Voth will send their contact information to Full Circle HOA Management for distribution.

Motion by Bill Threlfall, second by Gail Phoebus, to approve the proposed 2021 Operating Budget as presented. *All in favor, motion passes unanimously*.

Roads

- The 2020 operating surplus (\$16,000) will be split between road operation fund and operating fund.

- Spring maintenance expense reviewed. With Ron Kurucz's agreement the budget for repair and maintenance was increased. No corrugation or road base exposure has been reported so repairs were successful.
- No gate maintenance this year.
- Discussion of snow fencing.
- Discussion of weed mitigation.
- Traffic count on Dave Wood Road noted. Discussion of County road safety and cost share.
- Ownership thanks Bill Threlfall, John Merz and Bill Sims for a decade of service.

Motion by Bill Threlfall, second by John Merz, to approve the proposed 2020 Road Budget as presented. *All in favor, motion passes unanimously*.
